
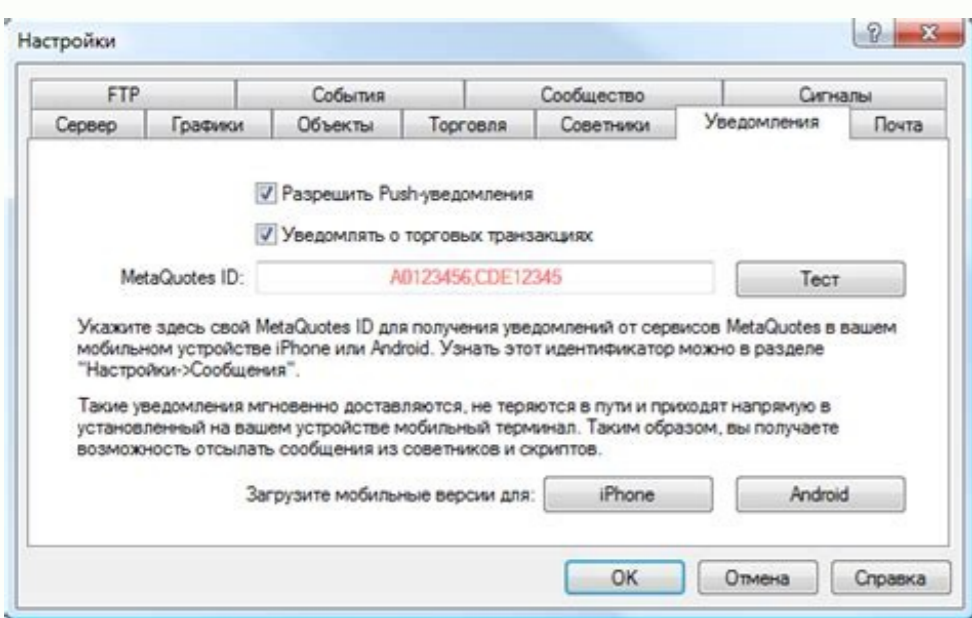

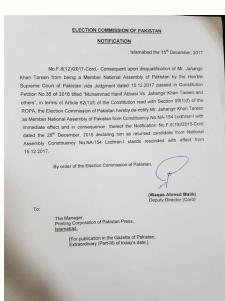
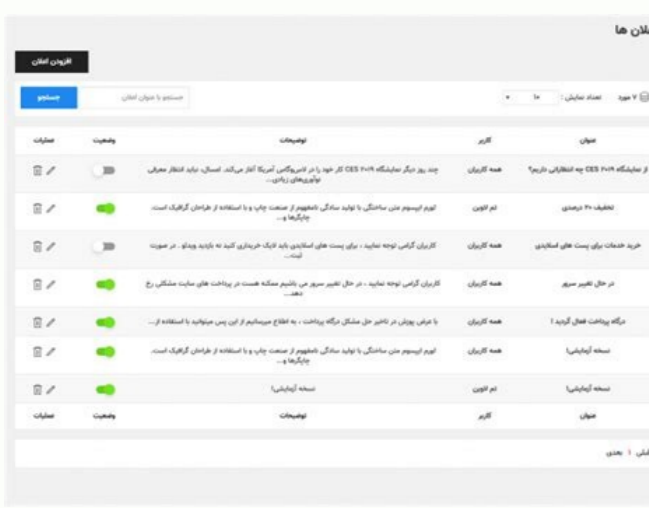

Prepare and e-file your federal tax return. Our policy prohibits the use of permanent Internet cookies. To view your balance owed, payment history or other information from your tax account, create or view your account. It provides a free option to taxpayers whose income (AGI) is greater than \$73,000. The IRS does not allow electronic filing for prior year returns through self-preparation websites. If you do not know last year's AGI, have a copy of your prior year tax return, you can find that information by signing into your online account. To change your bank account information on file, refer to the IRS Procedures guidance, What should I do if I entered an incorrect routing or account number for direct deposit of my refund? These are deleted when your Internet visit ends. IRS Free File Program offers the most commonly filed forms and schedules for taxpayers. To change your address on file, refer to the IRS Procedures guidance, How to notify the IRS my address has changed. The online tax preparation software partners are part of the Free File Alliance, which coordinates with the IRS to provide free electronic federal tax preparation and filing to you. The IRS Free File program PPF is not a traditional contractual arrangement; this partnership represents a balance of joint responsibility and collaboration that serves the interests of taxpayers and the Federal government. Please note you can only file your current year tax return using IRS Free File. Taxpayers whose AGI is \$73,000 or less qualify for a free federal tax return. We do not collect or retain information about you when you use IRS Free File. Going directly to a company's website will result in not receiving the benefits offered here. IRS Free File lets you prepare and file your federal income tax online using guided tax preparation, at an IRS partner site or Free File Fillable Forms. Once you click your desired IRS Free File provider, you will leave the IRS.gov website and land on the IRS Free File provider's website. Choose an IRS Free File option, guided tax preparation or Free File Fillable Forms. Prior year returns can only be filed electronically by registered tax preparers for the two previous tax years. To sign your electronic tax return, use a 5 digit self-select PIN, any five numbers (except all zeros) that you choose which serves as your electronic signature. The IRS Free File program is a Public-Private Partnership (PPP) between the IRS and the Free File Alliance, a coalition of leading tax preparation software companies. Contact Information To get a notification from the Free File software company that your return was accepted by IRS, you need a valid email address. You can also ask your tax preparer for electronic payment options. You cannot process a prior year return using IRS Free File. If you are unable to access your online account, you can get a tax return transcript by mail showing your prior year AGI. These companies are also subject to the Federal Trade Commission Privacy and Safeguards Rules and IRS e-file regulations. This is the fastest and easiest way to view your prior year adjusted gross income (AGI) and access your tax records. The IRS does not endorse any individual partner company. Depending on the type of transcript you request, you'll get more or less of the information from your return. Free File partner companies may not disclose or use tax return information for purposes other than tax return preparation without your informed and voluntary consent.
